## ALL ROADS LEAD TO CHEYENNE NOV 17-Dec 1

The Cheyenne Livestock Exposition with \$100,000+ in cash and prizes available to exhibitors will be held the last two weeks in November at the Laramie County Events Complex in Cheyenne.

The Cheyenne Livestock Expo was formed by a group of industry members. The event is aimed at preserving our nation's western heritage, giving stockmen from across the county the opportunity to showcase and promote elite genetics.

The event will be held at the all-new Event Center at Archer – an indoor barn and show ring with a capacity of 600-head of haltered cattle. "Archer" is temperature-controlled with an air filtration system. The facility includes an abundance of wash rack space, added electricity, and the show has secured interlocking floor mats. We have plenty of tie out space, and the opportunity for exhibitors to tie out at their trailers.

The 2024 livestock event will feature open and junior beef cattle breed shows with cattle stalled and shown under the same roof. The American Highland, Hereford, Mini Hereford and Dexter Associations will be having points shows.

\$45,000 will be awarded to the exhibitors of the top five bulls, open females, junior females. Additionally, premiums will be paid for breed show winners

For juniors, a market steer show, prospect steer and heifer shows will be held. \$6750 in cash prizes will be awarded to the top 5 market steers. The exhibitors of the top five Prospect Steer will be awarded \$6750. The exhibitors of the top five Prospect Heifers will be awarded \$4500. Market and prospects will also offer showmanship.

Junior sheep and goat exhibitors can take part in market, breeding and showmanship where champions will compete head-to-head during the supreme drives with \$21,000 total awarded to the exhibitors of the supreme champion market lamb and market goat.

Located in the heart of America in cattle country, Cheyenne was the obvious choice to hold this event where two major interstates intersect (I-80 and I-25) offering great options for lodging and some of the best food in the country.

We are excited to welcome you to the Cheyenne Livestock Exposition to be held November 17-Dec. 1, 2024. **Early entries** close November 1, 2024. For an additional fee you can enter through the show (on top of regular entry fees).

**GENERAL INFORMATION**

**WELCOME:** Welcome to the Cheyenne Livestock Exposition, to be held at the Event Center at Archer, in Cheyenne, Wyo. We encourage your participation. We are pleased to host you and your exhibits during this livestock events while you enjoy your stay in Cheyenne.

**MISSION STATEMENT:** Our mission is to offer you an opportunity to exhibit and market your cattle, exhibit your junior market and breeding stock with others in the livestock industry.

**COMPETITION:** Competition is open to the world except where otherwise specified.

**AGREEMENT OF RESPONSIBILITY:** At no time will the Cheyenne Livestock Exposition assume care, custody or control of any animals and/ or personal property of any exhibitor. Exhibitors will have full custody and control, and will care for, feed and keep safe their animals, livestock and personal property, all in accordance with the rules and regulations of the Cheyenne Livestock Expo Show Management.

**CHEYENNE LIVESTOCK EXPOSITION COURTESY STATEMENT:** In any barn the Cheyenne Livestock Expo Management Group expects that all exhibitors will extend courtesy to the public, other exhibitors and their animal exhibits. This includes respect for designated areas, informational signage and division barriers. Any questions regarding this should be referred to the Superintendent.

**PARKING:** No vehicle parking permits; however, it is recommended that livestock exhibitor vehicles park in places designated by the Cheyenne Livestock Expo. The Cheyenne Livestock Expo assumes no obligation and no liability for any theft or damage that may occur to the vehicle or its contents. No vehicles will be allowed to park for the sole purpose of advertising. All trucks – half-ton or larger and livestock trailers will be required, immediately after unloading, to park in designated areas. Except for those hog exhibitors that have purchased a premier trailer parking spot.

**MOTORIZED AUXILIARY VEHICLES:** No motorized utility vehicles such as 4-wheelers, golf carts, etc. will be allowed on the grounds during the Cheyenne Livestock Expo.

**FIRE REGULATIONS:** No smoking/vaping in any buildings or barns. No flammable liquids are allowed in any buildings.

**ALCOHOL ABUSE:** To safeguard exhibitors, livestock and the public, the State of Wyoming Rules on Alcohol Use and Abuse will be enforced. Excessive use of alcohol will not be tolerated. No one under the age of 21 is permitted to drink alcoholic beverages. Security and the State Patrol may be called if necessary.

**SMOKING/VAPING:** To safeguard exhibitors and livestock, smoking and vaping is prohibited in all barns. Smoking/vaping is only allowed outside the buildings and barns. All exhibitors and guests are asked to cooperate with us in enforcing this rule.

**FEED AND BEDDING:** The first bedding will be provided for exhibitors in the barn and the pen cattle. Bedding will need to be purchased for the tie-out area. Exhibitors will be permitted to bring onto the grounds a limited amount of feed, hay or straw.

**CHECK-IN TRAILER HOURS:** Will be open 6 a.m. to 10 p.m. on move-in days. They will be open for limited hours otherwise. Check the Cheyenne Livestock Exposition website, [www.greatnorthernlivestockexpo.com](http://www.greatnorthernlivestockexpo.com) for any updates. Also, please check prior to your arrival for any time changes. If you will be late or delayed for some reason, please call ahead.

**LOTTERY:** No lottery or raffle shall be conducted at the Cheyenne Livestock Exposition without the written authority of the Board of Directors.

**DOGS:** Due to requirements of the liability insurance carrier and policy of all major livestock shows, NO dogs are allowed on the grounds, in parking lots or in buildings other than those for direct competition or service animals. All dogs must be on a leash. There shall be no loose or unattended dogs on the fairgrounds. No dogs will be permitted in the animal barns, or in tie outs.

**SOLICITATION:** All advertising and/or distribution of advertising materials, tracts, pamphlets, etc. must be confined to a leased location. No roving solicitation is allowed on the grounds.

**MEDIA** News media services for obtaining reports of judges, awards, daily programs, special orders and announcements, Official decisions and all matters of interest or value to the public are available through the Cheyenne Livestock Exposition website: [www.cheyennelivestockexpo.com](http://www.cheyennelivestockexpo.com) or by contacting management.

## General Regulation

- 1. GENERAL INFORMATION:** The General Information is considered a part of the Cheyenne Livestock Exposition General Rules and Regulations. The following General Rules & Regulations apply to all departments. Please refer to each department for specific rules and requirements. Exhibitors are required to read ALL rules and regulations which pertain to the division they are entering. In the event of conflict of general and specific rules, the latter will govern. It is the responsibility of each exhibitor to be familiar with all applicable Rules & Regulations.
- 2. PREAMBLE:** The Cheyenne Livestock Exposition is being organized and operated for the purpose of providing an opportunity for producers to exhibit their livestock. The Cheyenne Livestock Exposition will provide educational opportunities for exhibitors and sponsors through the presentation of livestock exhibits. These exhibitions educate the livestock industry and the general public in better breeding, feeding and care of livestock. The Cheyenne Livestock Exposition arranges for the judging and presentation of premiums, prizes and the like, in continuation of such exhibitions and/or shows.
- 3. INTERPRETATION OF RULES AND DISPUTES:** The Cheyenne Livestock Exposition Management Group reserves the final and absolute right to interpret, amend or add to these Rules & Regulations as its judgment may determine, and to settle all disputes and determine all matters, questions and differences in regard hereto or otherwise arising out of, connected with, or incident to the Cheyenne Livestock Exposition.
- 4. FAIR LIABILITY:** The Cheyenne Livestock Exposition Management under no circumstances, will be responsible for personal injury, and assumes no liability for loss or damage of any nature to any property of the concessionaire, exhibitor or patron while on the grounds or at any time or place due to theft, fire, tornado, weather conditions, or other causes, nor be liable for or make any payment for the value thereof.
- 5. VIOLATION:** All exhibitors are bound by the most current editions of Rules & Regulations and will subject exhibitors to any penalties as the Cheyenne Livestock Exposition may order and/or penalties prescribed by law.
- 6. EXHIBITOR COMPLIANCE:** Exhibitors and their associates must cooperate with all Cheyenne officials including office clerks, grounds, admission, security and parking personnel and volunteers in all matters of policy. The Cheyenne Livestock Exposition's General Livestock Information, Rules & Regulations, Health Requirements will govern. By submitting an application for entry, exhibitors agree to comply with all Rules & Regulations governing the Cheyenne Livestock Exposition as referenced in these Rules and available on the Cheyenne Livestock Exposition website.
- 7. VOLUNTARY WAIVER:** The exhibitor agrees that the interpretation and enforcement of the Rules & Regulations by the Cheyenne Livestock Exposition shall be final, without further complaint, appeal, claim, lawsuit or other recourse against the Cheyenne Livestock Exposition. By submitting applications for entry, all exhibitors waive any right to challenge the Cheyenne Livestock Exposition's determinations in that regard.
- 8. SCHEDULE OF EVENTS:** The Cheyenne Livestock Exposition Management Group reserves the right to cancel events or change scheduling if deemed necessary.
- 9. EQUAL OPPORTUNITY:** The Cheyenne Livestock Exposition management provides to all persons the opportunity to exhibit at the Event without regard to race, creed, color, sex, age or other non-merit factors. Any discrimination will be prohibited.
- 10. APPLICATION FOR ENTRY:** By submitting an application for entry, Participant acknowledges they have read the General Livestock Rules and Regulations; specific and/or special division rules and regulations, and the National Show Ring Code of Ethics, and agrees to observe and abide by these rules and regulations.
- 11. ENTRY REQUIREMENTS:** All applications for entry must be made online at [www.cheyennelivestockexpo.com](http://www.cheyennelivestockexpo.com). Entry deadline is October 15, 2023. Entries must be accompanied by all fees and other sums due the Cheyenne Livestock Exposition or entry will not be accepted.
- 12. PLACEMENT:** No animal or article will be entitled to a place on the grounds until proper entry has been made. The Cheyenne Livestock Exposition shall reserve the right to vacate or order the removal of any entry which has been found to be entered in violation of the entry requirements. Should any individual enter an animal in a name other than that of a bona fide owner or attempt to perpetuate a fraud by misrepresenting any fact, the entry thus made shall not be allowed to compete for or receive any award, and the owner shall be barred from this show until reinstated.

Unless otherwise stipulated, entries and competition are open to the public. No animal will be considered unless provided for in the Entry Premium Book. All pertinent information including animal's name and date of birth must be recorded on the entry form. All animals shown shall have been the property of the exhibitor at least thirty (30) days prior to the opening of the Event and must show on the records of the breed association in which they are recorded.

Original registration papers or a certificate of ownership must be available for inspection at check-in time. In case of inability to get animals recorded before the time limit, a certified copy of the animal's pedigree on a regular breed application blank must also be available for inspection at check-in time. This certificate of application is to be signed by both parties of the transaction and must agree with breed association records. No papers need to be faxed in. In case of dispute as to age of an animal exhibited, its certificate of registry shall be required for evidence of its age, and its owner shall be required to file an affidavit that it is the identical animal therein described.
- 13. OWNERSHIP OF ANIMALS:** Breeding animals in the junior show must be the property of the owner and transferred on or before November 18, 2024. Animals cannot change ownership or be transferred from one program to the other.

**14. ERRONEOUS ENTRY:** Participants are responsible for their own entries, and those of their representatives, in preparation of entries. Animals that have been erroneously entered may be transferred, at the discretion of the Superintendent of the department, to their proper class, prior to judging, upon application to the Cheyenne Livestock Exposition, who will determine the matter upon its merits. If such classes have been judged, they shall not be reopened. **RETURNED CHECKS:** Any exhibitor issuing a check for payment, which is returned as non-sufficient funds or for any other reason not clearing their account, will be charged a \$40 service charge. No exhibitor will be permitted to show until the non-sufficient check has been paid. The exhibitor will have five (5) working days within which to make payment, by cash, cashier's check or money order, in the amount of the outstanding check plus the service charge. If any check is returned after the exhibitor has shown, all premiums will be held until the amount of the check plus the service charge is paid.

**15. CHECK IN PROCEDURES:** All necessary paperwork must be in order to complete the check-in process. Prior to showing, all animals must be checked in by an authorized Cheyenne Livestock Expo or breed representative. Tattoos or ear tags may be read and registration papers checked.

**16. LATE ENTRIES:** Anyone wishing to make an entry after the closing date, November 1st, may do so with an added late fee as stipulated in The Showman App.

**17. SUBSTITUTIONS:** Substitutions within the same class and the same owner only will be accepted. There will be no substitution of animals in different classes. Only one (1) substitution for the original animal will be allowed. All Substitutions must be approved by The Cheyenne Expo Management and will be final.

**18. HEALTH REQUIREMENTS:** All exhibitors must comply with the respective Livestock Health Requirements (see Livestock Health Requirements Section). All livestock are subject to examination, upon arrival, for evidence of infectious or contagious diseases and if such is found, they will not be allowed entrance onto the grounds. They will be held in quarantine and treated at the owner's expense or sent home. Diseased or injured animals may be removed from the grounds upon recommendation of attending veterinarian and release signed by the Department Superintendent and the Cheyenne Livestock Exposition Management.

**19.** Special prizes or awards may be listed within the breeds. The Cheyenne Livestock Exposition will not be held liable for any award or premium offered by an individual or company, separate from the Cheyenne Livestock Exposition, should that individual or company fail to provide the offered award or premium.

**It is the intention of Show Management that no premium or distinction of any kind be given to any exhibit deemed unworthy by the judge, or any exhibitor who has conducted herself or himself in a manner inconsistent with the goals and values of the Livestock Show. Such conduct may include, but not be limited to, theft of property, crude or crass behavior toward show personnel, exhibitors or spectators, or other actions amounting to moral turpitude on the part of the exhibitor or otherwise inconsistent with the spirit of fair competition.**

**20. JUDGES / JUDGING:** All judges' decisions are final. No person shall be permitted to judge a class in which he/she may be competing for an award or have an ownership of any animal or article entered in such class. Judges are earnestly requested to familiarize themselves with the Rules & Regulations of this show. If any exhibitor interferes with the judges in the performance of their duties by letter, act, or otherwise, he/she shall be excused from competition and exhibition for such period of time as Management may determine and shall forfeit any awards received at this Show. Any person, not an exhibitor, who interferes with the judges in any manner during the performance of their duties, shall be asked to leave the judging arena. When there are three (3) judges making a placing, the decision of two (2) shall be conclusive.

**21. BREED REGISTRATION AND PRACTICES:** An animal is eligible to enter or compete in the Cheyenne Livestock Exposition in only one (1) breed classification regardless if the animal is registered in one (1) or more breed associations or registries. Furthermore, the animal must be registered in the recognized U.S. registry for their breed classification or, if registered in the country of origin outside the U.S., the animal must be eligible for registry in the recognized U.S. registry. Each breed association shall have the sole responsibility to assure that its breed registration rules, regulations, procedures, and/or other communications including by way of illustration but not limitation, those relating to percentages of permitted cross breeding, are providing reasonable information to all parties relying upon its breed registration programs and to avoid any deceptive practices and/or unlawful conduct whatsoever. Each Association shall further indemnify, save and hold the Cheyenne Livestock Exposition and the city of Cheyenne and Laramie County harmless against any and all losses, claims, costs and/or expenses, including reasonable attorneys' fees and expenses and court costs, resulting from any loss of claims or legal action of any nature whatsoever, whether or not reduced to judgment, for any liability of any nature whatsoever that may arise against the Cheyenne Livestock Exposition relating in any way to the development and/ or implementation of the breed association's breed registration rules, regulations and/or procedures.

**22. INHUMANE TREATMENT OF ANIMALS:** The Cheyenne Livestock Exposition is committed to the humane treatment of all animals exhibited at the Show. Every possible precaution is taken to ensure the animals' safety and well-being. The production practices in the livestock industry are based on good principles of animal husbandry. It is the responsibility of all exhibitors to provide proper care and treatment to animals. Abuse of animals in any form will not be tolerated. No electric prods will be allowed to be used on any animal at any time. Cheyenne Livestock Exposition Management reserves the right to disqualify and remove any exhibitor deemed in violation of the basic principles of animal husbandry, with no recourse. Animal care procedures are outlined in our "Animal Welfare Policy".

**23. TREATMENT OF SICK MARKET ANIMALS:** If an animal requires emergency treatment while on the Fairgrounds, only the Official Cheyenne Livestock Exposition Veterinarian will be allowed to administer any drug, chemical or feed additive to that sick animal. The Official Cheyenne Livestock Exposition Veterinarian, in agreement with Cheyenne Livestock Exposition Management, reserves the right to treat any animal if, in the opinion of the Official Cheyenne Livestock Exposition Veterinarian it is in the best interest of the animal's health and well-being to be treated.

**24. ANIMAL RULES/STATEMENT OF PURPOSE:** To foster fair competition, to provide a level playing field and to protect the safety of food, the following will be prohibited: the showing of unethically fitted animals, livestock of any ineligible age for exhibition in

the class entered, and/or animals in violation of rules on prohibited substances.

**25. UNETHICAL FITTING/PROHIBITED SUBSTANCE, UNAPPROVED DRUG USE, APPROVED DRUG USE, DRUG TESTING:** The Cheyenne Livestock Exposition reserves the right to question the alteration of any animal's physical or physiological structure. As a condition of participation in the Cheyenne Livestock Exposition, exhibitors agree to submit to Show Management, at its discretion and request, any animal so entered for examination and/or immediate drug testing.

**26. UNETHICAL FITTING/PROHIBITED SUBSTANCE:** Unethical fitting and/or prohibited substances shall be defined as: the injection, use or administration of any drug or substance that is prohibited by Federal, State, or Local Law, or any drug that is used in a manner prohibited by Federal, State, or Local Law; the injection (or internal or external administration) of any product or material, whether gas, solid, or liquid, to an animal for the purpose of deception, including concealing, enhancing, or transforming the true conformation, degree of firmness, color, breed, condition of age, or by making the animal appear sounder than otherwise would appear; cutting or tearing of the hide, cutting or tearing underneath the hide, or removal of tissue in any attempt to alter, change, or modify the shape or appearance; any artificial means of removing or remedying physical defects or conformation (i.e. doctoring, doping, tubing, injecting, or lifting or filling under the skin); any type of injection where oils, glycerin or like substances are used to alter and change the conformation of an animal; the administration, use or application of any drug, feed additive, or substance affecting the central nervous system; the administration of diuretics for cosmetic purposes, tissue manipulation, removal, surgical attachment or otherwise to change, conceal, enhance, or transform the true conformation or configuration of the animal; any unnatural means of providing an animal feed, water, or other fluids (i.e. stomach pump, I.V.) with the exception of the drenching process; any physical or physiological attempt to alter the natural musculature or weight by use of injections or ingested material not conducive to the continued health and marketability of beef, sheep, swine, or goat carcasses or for deception.

Artificial color (paint) will be allowed on cattle, but any attempt to change the original color and/or markings of the animal will be prohibited. Prohibited practices also include the use of artificial tail-heads, switches, polls and hair as well as any internal or external hoof treatments or artificial substances meant to improve soundness; external applications of such things as liniments and blistering agents that would cause edematous condition; use of ice packs or other refrigerants to alter the quality of the finish of an animal.

**27. STALLS, TACK STALLS AND TIE OUTS:** All "stall with" requests must be submitted online with the entry. There is no guarantee the request can or will be honored. The Cheyenne Livestock Exposition Superintendents will assign stall space within the barns at the time entry fees are paid in full. Tie spaces will be assigned by Expo Superintendents, or in some cases breed representatives. Any tampering with other exhibitors' stalls or tie-out stalls will not be tolerated. All tieouts will be assigned by a beef superintendent with NO first come first served. Tieout pens are available at \$25 per pen for the duration of either Breeding Cattle Week or Prospect Weekend but a separate fee will be collected for each. There will be a designated area east of the tie out pens that you can tie to or in your trailers. Please stay in that area and dispose of your trash.

**28. GENERATORS, BLOCKING CHUTES, PORTABLE SCALES:** No generators will be allowed in the barns at any time. Generators will be allowed only outside the barns, in the tie out area. Scales in the Barns will be provided by the Cheyenne Livestock Exposition.

**29. FANS, EXTENSION CORDS AND ELECTRICAL DEVICES:** All fans, extension cords and electrical appliances used in the livestock barns must have a ground, must have safe wiring and must be in safe working condition. All fans used in the barns must have a protective screen (front and back). Free standing fans will not be allowed. Hanging fans will only be allowed when attached to the tie rails or to supports attached to the tie rails. No fans attached to a cart or dolly. Only 1 fan per animal! All fans must be hung to the left of the beef animals and above the stalling area to help with air circulation. Any and all persons participating in any and all events covered by this entry catalog hereby acknowledge the following:

- A. The superintendent has the express authority to determine if any fan, extension cord or other electrical device complies with this rule.
- B. Should the superintendent determine that a fan, extension cord or other electrical device does not comply with this provision; the superintendent has the authority to require that the use of the fan, extension cord or other electrical device be immediately discontinued.
- C. Failure to comply with this provision in a timely manner shall be grounds for immediate dismissal from continued participation in the Show and the forfeiture of all entry fees, charges, ribbons, championships and premiums awarded.
- D. Any and all persons participating in any and all events covered by these Rules & Regulations are responsible for performing all steps necessary to assure that any fans, extension cords and other electrical devices are in good repair and free of dangerous conditions or defects. Pursuant to the provision of these Rules the Show may, but has no duty to do so, determine if any fan, extension cord or other electrical device meets these requirements established in this portion of these Rules & Regulations.

**30. SHOW BACK NUMBERS:** Each animal entered in the Cheyenne Livestock Exposition may be assigned a number. Those numbers may be given to each exhibitor as a back number at the time of check-in. It is the exhibitor's responsibility to have the correct back number displayed on their back or in a holder attached to the waist before entering the show ring. If the back number does not correspond with the original entry on the official judge's sheet, the result may be disqualification of that animal.

**31. INTERNATIONAL ASSOCIATION OF FAIRS AND EXPOSITIONS (IAFE) NATIONAL CODE OF SHOW RING ETHICS:** Exhibitors of animals at livestock shows shall at all times deport themselves with honesty and good sportsmanship. Their conduct in this competitive environment shall always reflect the highest standards of honor and dignity to promote the advancement of agricultural education. This code applies to junior as well as open class exhibitors who compete in structured classes of competition. This code applies to all livestock offered in any event at a livestock show. In addition to the "IAFE National Code of Show Ring Ethics", fairs and livestock shows may have rules and regulations which they impose on the local, county, state, provincial and national levels.



All youth leaders working with junior exhibitors are under an affirmative responsibility to do more than avoid improper conduct or questionable acts. Their moral values must be so certain and positive that those younger and more pliable will be influenced by their fine example. Owners, exhibitors, fitters, trainers and absolutely responsible persons who violate the code of ethics will forfeit premiums, awards and auction proceeds and shall be prohibited from future exhibition in accordance with the rules adopted by the respective fairs and livestock shows. Exhibitors who violate this code of ethics demean the integrity of all livestock exhibitors and should be prohibited from competition at all livestock shows in the United States and Canada.

**32. PROTESTS:** The Cheyenne Livestock Exposition will handle ALL protests. Verbal protests will be directed to the proper species superintendent and if necessary, brought to the Livestock Show Management. All formal protests must be submitted in writing to the Cheyenne Livestock Exposition Management Group. All forms must be signed by three individuals, and be accompanied by a monetary fee of \$500, cash or certified check. Such written protests must state plainly the cause of complaint or appeal and must be filed with the Livestock Show Management immediately upon the occasion of the protest. No complaint or appeal based solely upon the statement that a judge is incompetent will be considered by Management. This complaint, along with supporting documents, will be submitted to the Cheyenne Livestock Exposition Management Superintendent. The report of wrongdoing will then be presented to a neutral panel appointed by the superintendent for review. The panel shall review the form, the allegations, and the supporting documents or evidence and report its findings and proposed decision to the Cheyenne Livestock Exposition Superintendent. At no time will any exhibition, judging event, or any other ongoing event be delayed, stopped or interrupted as a result of any allegation of wrongdoing. Where a formal protest is to be made against the competition of an animal or article in any class, notice of the same must be filed with the Department Superintendent before the class is judged or prior to any Division or Grand Champion Drive. Once an animal/exhibit reaches championship judging, NO protests will be accepted. Any decision rendered by the Cheyenne Livestock Exposition Management based upon the review and proposed decision of the neutral panel shall be deemed a final decision.

**33. STATE FIRE MARSHAL:** By order of the State Fire Marshal, the use of flammable and combustible grooming sprays inside the barns is strictly prohibited. These types of materials must be used outside of the buildings only. Any and all lighting used by exhibitors must be securely fastened. In addition, any use of refrigerators, freezers, microwaves, ovens and electric cookers is strictly prohibited. This will be enforced!

**34. CONCESSIONS AND ADVERTISING PRIVILEGES:** All exhibits, concessions and/or commercial privileges are at the sole discretion of Show Management. Under no circumstances will any advertising material be allowed to be placed upon buildings, trees or other places on the grounds or otherwise distributed without Management permission.

**35. EXHIBITOR LIABILITY:** Exhibitors of livestock must exercise due discretion in regard to the animals they are exhibiting, whether in the ring, stall or pen and exhibitors must assume responsibility for any damages caused by or to their animals. The exhibitor will be solely responsible for any consequential or other loss, injury or damage done to, or occasioned by, or arising from any animal or article exhibited by him/her and for its description as given in the Rules & Regulations. Exhibitor shall indemnify the Cheyenne Livestock Exposition against all legal or other proceedings in regard thereto, as well as any damage or injury to any other person or property, caused by the exhibitor or any of the animals exhibited with the Show.

**36. PHOTOGRAPHS:** The Cheyenne Livestock Exposition will hire a professional photographer as the official photographer who will take the official photographs for the Show. The official photographer has exclusive rights for use of the backdrop area for photos. Exhibitors must agree to present themselves and their animal(s) at the request of show officials for official photographs. Official photographs are those that will be used for promotional purposes or used in any official publications. Unofficial photographs MAY NOT be published without written approval of management. Exhibitors wishing to purchase photographs must contact the Official Photographer.

As a Cheyenne Livestock Exposition exhibitor, you acknowledge that your photograph may be taken by the official Cheyenne Livestock Exposition Photographer for use by the Cheyenne Livestock Exposition and agree to release and hold harmless the Cheyenne Livestock Exposition Management Group, their employees and agents and any and all parties to whom this or any photograph may be released. This photograph will be taken for artistic reasons or newsworthiness and you agree that it may be released to any medium and may be used in any manner for any purpose whatsoever without compensation.

**37. FORCE MAJEURE:** The Cheyenne Livestock Exposition shall not be liable for any delay or failure to perform its operations, activities, shows, and events to the extent such delay or failure results from force majeure occurrence. A force majeure occurrence is defined as any occurrence arising from cases beyond the reasonable control of the Cheyenne Livestock Exposition, including the health threat of COVID-19 and similar infectious diseases, and which delays or prevents performance by the Cheyenne Livestock Exposition otherwise required by this Agreement, including but not limited to any (i) breakage or accident of equipment, machinery or facilities; (ii) any strikes, lock-outs or other labor difficulties; (iii) statutes, ordinances, regulations, orders, or rules issued by governmental authorities; (iv) judicial decrees or orders; (v) acts of God; (vi) animal diseases and/or quarantines; (vii) wars, riots or insurrections; (viii) civil disturbances, public demonstrations or sabotage; (ix) fires, floods, explosions or inclement weather; (x) inability to obtain necessary labor, materials, supplies, utilities or transportation; (xi) depressions, recessions or other economic downturns; (xii) embargoes or energy shortages; or (xiii) other causes beyond the Cheyenne Livestock Exposition's reasonable control.

**38. GOVERNMENTAL REGULATION:** The Cheyenne Livestock Exposition shall not be liable for any delay or failure to perform its operations, activities, shows and events to the extent such delay or failure results from The Cheyenne Livestock Exposition's good faith compliance with applicable governmental statutes, ordinances, regulations, orders, rules or other directives, including but not limited to compliance with governmental directives concerning public health and safety, animal disease prevention, detections and response, including animal quarantine and/ or destruction; and protection of the environment.

# 2024 CHEYENNE LIVESTOCK EXPOSITION HEALTH AND BRAND REQUIREMENTS FOR ANIMALS EXHIBITED AND SOLD AT THE 2024 CHEYENNE LIVESTOCK EXPOSITION

The Cheyenne Livestock Exposition, in cooperation with the Wyoming State Veterinarian’s Office and the Wyoming Livestock Board, recognizes and abides by the importation laws of the state of Wyoming. The requirements in this document reflect the import and livestock movements of the Wyoming Livestock Board, as well as additional requirements from the Cheyenne Livestock Exposition.

Livestock disease control is vital for the livestock industry in Wyoming and the nation. Biosecurity is a key component of controlling diseases. Anytime animals are commingled, the chance of spreading disease is multiplied and so is the need for heightened biosecurity.

**If an emerging disease is detected in Wyoming or any other state, additional requirements may be put in place.**

## **CERTIFICATE OF VETERINARY INSPECTION (CVI)**

All animals entering the Laramie County Fairgrounds, Archer Event Center, must be accompanied by a current CVI and shall have official identification listed on the CVI. CVIs must list the Cheyenne Livestock Exposition as the destination. Each CVI must:

- a. Be an official form from the state or Province of origin,
- b. Be issued by an accredited licensed veterinarian.
- c. Show name and address of owner or exhibitor.
- d. Show all required tests and/or vaccinations for import into Wyoming.

CVIs must be issued within thirty (30) days of the exhibition. EXCEPTION – shorn sheep and meat goats (15 days). All sale animals must have one animal listed per CVI with the CVI original plus three (3) copies.

***\*\*Wyoming is a brand inspection state. Check the section on Brand Inspection for details.***

## **GENERAL HEALTH REQUIREMENTS**

1. Representatives of the State Veterinarian’s Office will be in attendance to verify CVIs.
2. Under no circumstances may animals under quarantine be exhibited.
3. Only animals not showing signs of infectious or contagious diseases will be allowed to show.
4. Animals that have active ringworm, lesions, visible warts, dermatitis or abscesses will not be allowed entry into the Cheyenne Livestock Exposition for exhibition.
5. The inspecting veterinarian may judge the ringworm to be inactive if the lesion is not encrusted and hair/wool has begun re-growth in the area and is so stated on the CVI.
6. All animals entering the Cheyenne Livestock Exposition will be subject to examination by a Cheyenne Livestock Exposition show veterinarian upon arrival or during the show. Any animal showing evidence of infectious, contagious or communicable diseases may be immediately withdrawn from the show and held in quarantine at owner’s risk and expense until properly treated and recovered or until properly released to return to owner’s premises following treatment.
7. Animals with ringworm or warts that are visible by a hands-on inspection will not be allowed to remain on the premises.
8. Any animals not from Wyoming that are sold or staying in Wyoming after exhibition must meet Wyoming import requirements. All out-of-state bovine animals must meet the TB and Brucellosis requirements as described within this document.
9. List official identification (steel tags, individual animal breed registry tattoos, or 840 RFID tags) which are correlated to official identification, on the CVI and accompanying certification where necessary.
10. Regardless of origin, all sale animals must meet the following requirements for transportation from the Event Center at Archer to any state in the continental United States.

**IMPORTANT:** All sale animals must arrive with the proper testing/requirements for Brucellosis, Tuberculosis, Scabies, Trich, and Anaplasmosis/ Bluetongue. All sale animals must have ONE (1) animal listed per CVI with the CVI original plus three (3) copies.

## **WYOMING ORIGIN SHOW ANIMALS**

**BEEF CATTLE (CVI with official ID listed):** All cattle must be individually identified with official ID on the CVI. Accessory ID devices are more easily read, but need to be listed and correlated to official identification (steel tags, tattoos, or 840 tags) on the CVI. Individual animal breed registry tattoos **must be accompanied by breed registry certification papers.**

**A. TUBERCULOSIS**

No test required to exhibit. Must be from a herd not under quarantine.

**B. BRUCELLOSIS**

Female sexually intact cattle originating from the Designated Surveillance Area (DSA), including female cattle twelve (12) months of age and over, and any weaned, sexually intact female exposed to bulls, must be brucellosis tested within 30 days prior to leaving the DSA. Must be from a herd not under quarantine.

**C. TRICHOMONIASIS**

Bulls used for recreational and exhibition purposes shall remain under confinement at the recreational or exhibition premises and shall not be allowed to commingle with sexually intact female cattle. Sale bulls – see sale specific test requirements.

**D. ANAPLASMOSIS AND BLUE TONGUE**

A test is optional within 30 days for any sale animal, as animals may sell to some eastern states that require a negative test for either or both diseases.

**SHEEP AND GOATS (CVI with official ID listed):** A CVI must be issued within fifteen (15) days of exhibition for all shorn sheep and meat goats. CVI shall include the statement, "All animals in this Shipment are free from foot rot and ringworm (club lamb fungus) and originate from a flock/ herd that has not had scrapie in the past five (5) years."

A. All sheep being exhibited at the Cheyenne Livestock Exposition, may be examined for fungus prior to entering the fairgrounds or at unloading time. All sheep will be examined by a licensed Livestock Exposition veterinarian. Blankets must be removed. Market lambs may be examined at check-in/weigh-in and again prior to entering the show ring! All market lambs must be completely slick shorn, including belly, within one-quarter (¼) inch PRIOR to arrival at the show. Wool may be left on the legs only below the knees and hocks. If any live fungus is found, said animal will be removed from contacting other sheep and people, and not allowed to be shown.

B. Examination: All sheep and goats will be subject to reexamination before stalling. Sheep and goats with lesions of ringworm with resulting loss of wool/hair and/or sores that are not completely healed (with wool/hair regrowth) will not be allowed to exhibit. If signs of dermatitis, lesions, and/or fungus (ringworm) are visible, such animals will be immediately removed from the grounds.

C. Identification: All sheep and goats, regardless of age or gender being exhibited, must have USDA Official Scrapie Identification and must be listed on the CVI; individual animal breed registry tattoos **must be accompanied by breed registry certification papers.** 982 tags are NOT official USDA scrapie tags.

D. Under no circumstances may sheep or goats be exhibited which originate from scrapie-source flocks or scrapie-infected flocks.

F. TESTING: The Cheyenne Livestock Exposition Management reserves the right to administer random testing, to include DNA, urine, tissue, blood, and retinal scanning, for any foreign substances on any animal at any time while that animal is on the Archer Event Center premises. All Grand Champion or Reserve Grand Champion animals of each species may be tested. *The Show Management reserves the right to interpret the rules or make any decision regarding the show deemed necessary in the best interest of the show.*

G. Halters are permitted on goats.

**OUT-OF-STATE ORIGIN SHOW ANIMALS**

**BEEF CATTLE (CVI with official ID listed)** All out-of-state animals must have a current CVI and have an import permit. All cattle must be individually identified with an official ID on the CVI. Accessory ID devices are more easily read, but need to be listed and correlated to official identification (steel tags, tattoos, or 840 RFID tags) on the CVI. Individual animal breed registry tattoos must be accompanied by breed registry certification papers. If they are staying in Wyoming, they will need an official ID tag.

**A. TUBERCULOSIS**

1. Accredited-Free  
a. Beef cattle – no testing required.

2. Not Accredited Free or Modified Accredited State or Zone: Beef cattle which originate from a herd not under quarantine for tuberculosis shall have one negative tuberculosis test performed within sixty (60) days prior to importation.

**B. BRUCELLOSIS**

Class-Free states: no test required. Must be from a herd not under quarantine.

**C. TRICHOMONIASIS**

Any non-virgin bull or bull over eighteen (18) months of age shall have a negative PRC test conducted at an American Association of Veterinary Laboratory Diagnosticians (AAVLD) or equivalent accrediting organization approved laboratory, within sixty (60) days prior to entry with no female exposure 14 days prior to test and from the time of test until import. Sale bulls – see sale specific test requirements.

**D. ANAPLASMOSIS AND BLUETONGUE**

A test is optional within 30 days for any sale animal, as animals may sell to some eastern states that require a negative test for either

or both diseases.

**SHEEP AND GOATS (CVI with official ID listed):** A CVI must be issued within fifteen (15) days of exhibition for all shorn sheep and meat goats. CVI shall include the statement, "All animals in this shipment are free from foot rot and ringworm (club lamb fungus) and originate from a flock/herd that has not had scrapie in the past five (5) years."

**\*\* All Sheep and Goats need to have an import permit \*\***

A. All sheep being exhibited at the Cheyenne Livestock Exposition, may be examined for fungus prior to entering the fairgrounds or at unloading time. All sheep will be examined by a licensed Livestock Exposition veterinarian. Blankets must be removed. If any live fungus is found, said animal will not be allowed onto the grounds. Market lambs may be examined at check-in/weigh-in and again prior to entering the show ring! All market lambs must be completely slick shorn, including belly, within one-quarter ( $\frac{1}{4}$ ) inch PRIOR to arrival at the show. Wool may be left on the legs only below the knees and hocks. If any live fungus is found, said animal will be removed from contacting other sheep and people, and not allowed to be shown.

B. Examination: All sheep and goats will be subject to re-examination before stalling. Sheep and goats with lesions of ringworm with resulting loss of wool/hair and/or sores that are not completely healed (with wool/hair regrowth) will not be allowed to exhibit. If signs of dermatitis, lesions, and/or fungus (ringworm) are visible, such animals will be immediately removed from the grounds.

C. Identification: All sheep and goats, regardless of age or gender being exhibited, must have USDA Official Scrapie Identification and must be listed on the CVI; individual animal breed registry tattoos must be accompanied by breed registry certification papers. 982 tags are NOT official USDA scrapie tags.

D. Under no circumstances may sheep or goats be exhibited which originate from scrapie-source flocks or scrapie-infected flocks.

E. Black-faced sheep remaining in WY for reproductive purposes must meet genetic test requirements. All sexually intact black-faced sheep imported for reproductive purposes shall be tested "RR" or "QR" by an approved genetic susceptibility test for scrapie prior to importation, except:

(A) Sheep originating from an Export Certified Flock as defined in the Scrapie UM&R may have this testing requirement waived or modified with the prior written approval of the Wyoming State Veterinarian.

(B) Sheep fourteen (14) months of age or older, susceptible to scrapie on the genetics test (QQ) may be imported, if they are found negative to a scrapie live animal test prior to importation.

(C) Sheep less than fourteen (14) months of age, susceptible to scrapie on the genetics test (QQ) may be imported under quarantine to be tested with a scrapie live animal test immediately upon reaching fourteen (14) months of age.

F. TESTING: The Cheyenne Livestock Exposition Management reserves the right to administer random testing, to include DNA, urine, tissue, blood, and retinal scanning, for any foreign substances on any animal at any time while that animal is on the Archer Event Center premises. All Grand Champion or Reserve Grand Champion animals of each species may be tested. *The Show Management reserves the right to interpret the rules or make any decision regarding the show deemed necessary in the best interest of the show.*

#### **WYOMING OR OUT-OF-STATE ORIGIN SALE ANIMALS**

All Wyoming origin or out-of-state animals must have a current CVI. All out of state cattle are also required to have an import permit. All cattle must be individually identified with an official ID on the CVI. Accessory ID devices are more easily read, but need to be listed and correlated to official identification (steel tags, tattoos, or 840 RFID tags) on the CVI. Individual animal breed registry tattoos must be accompanied by breed registry certification papers.

#### **A. BRUCELLOSIS Females:**

a. Official Calfhood Vaccinated (OCV) with a legible Vaccination tattoo AND

b. Females 24 months of age and over must test negative within 30 days prior to sale date or be from a certified herd.

#### **Bulls:**

a. Bulls six months of age and over must test negative within 30 days prior to sale date or be from a USDA-certified free herd.

#### **B. TUBERCULOSIS**

All breeding animals must be tested and negative within 60 days prior to sale date or be from a USDA-accredited herd. If from a USDA-accredited herd, list the last whole herd test date. If the animals are coming from Michigan, please contact the Wyoming State Veterinarian's Office at 307-777-7515 for complete testing details.

#### **C. TRICHOMONIASIS**

All sale bulls 12 months of age or older shall have a negative PRC T. fetus test within 30 days prior to entry to the Cheyenne Livestock Exposition. Any female that will be sold to a Wyoming buyer cannot originate from a Trichomoniasis affected herd. Breeding females sold for breeding can meet Wyoming requirements via one of these protocols: (a) must be a virgin female; or (b) exposed to a bull that has been tested for Trichomoniasis or artificially inseminated; or (c) have a calf at side and not exposed to a bull; or (d) be at least 120-days bred.

#### **D. ANAPLASMOSIS AND BLUETONGUE**

A test is recommended within 30 days of sale date, as animals may sell to states that require a negative test for either or both diseases.

#### **CANADIAN ORIGIN SHOW & SALE ANIMALS**

Cattle entering the Cheyenne Livestock Exposition originating from Canada must meet all import requirements for the state of Wyoming. You will need a Canadian Veterinary Health Certificate (CVI) and Import Permit from Wyoming State Veterinarian's office 307-777-7515. Contact us for further information.

**BRAND INSPECTION** Wyoming is a Brand Inspection state. State law requires a brand inspection be completed on ANY livestock (horses, mules, cattle and sheep) prior to movement across a county or state line, and when a change of ownership occurs. All cattle

being sold at any Exposition sale must provide proof of ownership prior to the sale. This can be established through brand inspection documentation, use of the owner's registered brand, bill of sale or title document. Health documents from non-brand states are a valid piece of the puzzle, but must be augmented by other evidence of ownership, as above. If proof of ownership is not supplied, proceeds will be held until such proof is provided. All livestock leaving the event must have an inspection performed. If the livestock is from and returning to a brand state which provides for a Lifetime or Permanent permit, those will be honored. Brand inspectors will be available for any exposition sale and at the times posted at the event office. For questions concerning brand inspection, contact the Wyoming Brand Office at 307-777-7515.

1. Rules and Regulations. General Rules and Regulations apply to this division as well as those listed in Junior Breeding Show Rules and Regulations
2. We will start the show at 8:00 a.m. with one ring and alternate between two judges with one breed to show at the conclusion of the previous with no break.
3. Supreme Junior Heifer will follow the conclusion of all breeds, only breed Champions and Reserve Champions will be allowed in Supreme.

4. To be eligible to exhibit in this division, they must not be more than twenty-one (21) years as of January 1, 2024.
5. Junior breeding heifers may be entered in the open show in the name of the Junior using an Open Breeding Cattle entry form. Late entries according to The Showman App. They are also eligible to enter Prospect Breeding Heifers as well as Prospect Steer/Heifer classes as long as they officially enter.
6. All heifers must be registered in the National Herd Book of the breed. The entry must show the name, the age and the registration number of the competing animal.
7. All heifers must be the property of and in the possession of the Participant as of November 18, 2024. Ownership must be shown by breed registry issue/transfer date. Registration must be in the name of Participant as of November 18<sup>th</sup>, 2024. Those heifers sold in Breed Association sales will be allowed to be shown by Junior Exhibitors entering the heifer with approval of the new owner.

Early entry deadline is November 1, 2024, entries received after this date will be \$60. All entries must be owned by the exhibitor on or before the date of show. Pen fees \$10 for each pen requested.
3. All Market lambs must meet all Wyoming Health Requirements. (See Health Requirement section).
4. Animals entered in this division may be either wethers or ewes.
5. All market lambs must be completely slick shorn. Wool may be left on the legs only below the knees and hocks.
6. Wethers having one (1) or both testicles contained in the body cavity are ineligible to show.
7. Official Weight: The weight recorded at time of processing will become the official weight. All market lambs will be divided into classes according to this weight. Minimum weight for Market Lambs is one hundred (100) pounds. No maximum weight. Exhibitors will nominate weights through the Showman.app or upon check-in. The top 5 sheep in each class may be subject to weigh back and must be within **5lbs** of nominated weight.
8. All market lamb will be classified and may be divided into two or more equal classes by breeds at the discretion of Show Management, whose decision will be final, prior to showing.
9. Water: Water in a container must be present in each pen at all times.
10. Bedding: Shavings and bedding may be purchased. First bedding is **not** provided.
11. Penning: All hogs will be penned two(2) per pen based on entries at time of arrival (entries and pens must be paid for in the showman.app).
12. Market lambs may be examined by a show veterinarian upon arrival or during the show. Any animal showing evidence of infectious, contagious or communicable diseases may be withdrawn from the show and held in quarantine at owner's risk and expense until properly treated and recovered or until properly released to return to owner's premises following treatment. Animals with ringworm or warts that are visible by a hands-on inspection will not be allowed to remain on the premises.
13. Market lambs are subject to all rules and regulations concerning Inhumane Treatment of Animals, Unethical Fitting/ Prohibited Substance and the International Association of Fairs and Expositions (IAFE) National Code of Show Ring Ethics. See General Rules 24, 27 and 32.

7. Wethers having one (1) or both testicles contained in the body cavity are ineligible to show.
8. Official Weight: The weight recorded at time of processing will become the official weight. All market goats will be divided into classes according to this weight. Maximum weight is one hundred twenty five (125) pounds. The top 5 goats in each class may be subject weigh back and must be within **5lbs** of nominated weight.
9. Water: Water in a container must be present in each pen at all times.
10. Exhibitors may use collars or collars with a short lead when showing.
11. Bedding: Shavings and bedding may be purchased. First bedding is not provided.
12. Penning: All hogs will be penned two(2) per pen based on entries at time of arrival (entries and pens must be paid for in the showman.app).
13. Market goats will be examined by a show veterinarian upon arrival or during the show. Any animal showing evidence of infectious, contagious or communicable diseases may be withdrawn from the show and held in quarantine at owner's risk and expense until properly treated and recovered or until properly released to return to owner's premises following treatment. Animals with ringworm or warts that are visible by a hands-on inspection will not be allowed to remain on the premises.
